*Optional Charge; is a request for a payment for specific additional features above Ministry Of Education (MOE) regulations, or items you could provide for your child. 1. At Aspiring Beginnings Early Learning Centre, the optional charge *(as described in the “fees policy”)* is:

- \$1 per free hour to support the extra salary cost to have 80%+ ECE qualified & registered teachers, which exceeds the minimum regulation required by the Ministry of Education.
- \$5 per day when you opt for your child to receive our healthy heart daily menu.
- Advertised if we offer extracurricular activities during the year such as music, dance or transport costs for excursions. If you opt for your child to participate then the cost will be charged to your account.

2. I understand that if I agree to pay a regular Optional Charge, Aspiring Beginnings Early Learning Centre may enforce payment.

3. The agreement to pay the optional charge will last for twelve months from the date of this agreement or until the “fees policy” is reviewed, whichever comes first.

4. The rules about making changes to the agreement must be in writing at least one week prior if:

- You can no longer financially support paying the optional charge to help cover the extra cost of extra qualified & registered teachers.
- You no longer want your child to receive our meals or participate in extracurricular activities.

5. I understand that the optional charge is not compulsory and if I choose not to pay there will be no penalty.
